## SUMMARY

### Offer Price and net proceeds

- The Offer Price has been determined at HK\$1.00 per Offer Share (exclusive of 1.0% brokerage, SFC transaction levy of 0.0027% and Stock Exchange trading fee of 0.005%), being the mid-price of the stated range of the Offer Price in the Prospectus.
- Based on the Offer Price of HK\$1.00 per Offer Share, the net proceeds from the Share Offer to be received by the Company and after deducting the underwriting commissions and estimated expenses payable by the Company in relation to the Share Offer, is estimated to be approximately HK\$171.3 million. The Company intends to apply such net proceeds in accordance with the purposes set out in the section headed “Future plans and use of proceeds” in the Prospectus.

### Applications under the Public Offer

- The Offer Shares initially offered under the Public Offer have been significantly over-subscribed.
